

## FACTS WHAT DOES RESULTS MORTGAGE, LLC (NMLS #1458830) DO WITH YOUR PERSONAL INFORMATION?

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>■ sharing for affiliates' everyday business purposes - information about your creditworthiness</li> <li>■ affiliates from using your information to market to you</li> <li>■ sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account - unless you tell us otherwise.

## Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <b>RESULTS MORTGAGE, LLC (NMLS #1458830)</b>, affiliates include financial companies such as <b>STEARNS VENTURES, INC. and STEARNS LENDING, LLC</b>, and non-financial companies with common ownership or control such as <i>Collopy Real Estate, Inc., d/b/a RE/MAX Results</i>.</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>■ <b>RESULTS MORTGAGE, LLC (NMLS #1458830)</b> does not share with nonaffiliates to market to you.</li> </ul>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>■ <b>RESULTS MORTGAGE, LLC (NMLS #1458830)</b> does not jointly market</li> </ul>
